TERMS AND CONDITIONS

ARTIFICIAL INSEMINATION 2026

PAYMENT TERMS

- The Stud Fee and Collection Fee must be paid prior to collection of semen or prior to arrival at the stud.
- All fees are payable in pounds sterling.

ORDERING AND COLLECTION

- Semen **MUST** be ordered the day before collection is needed.
- Collections will not be made after 9:00am on the day of collection without prior notice.
- Mare owners are required to keep the stud regularly updated on the mare's progress to ensure semen can be made available when requested.
- Failure to provide regular updates and late orders may result in non-availability of semen.

COLLECTION FEE

- The collection fee is £135 per dose and is not included in the stud fee.

PACKAGING AND DELIVERY

- Semen will be dispatched upon receipt of cleared funds using specialized packaging.
- The packaging must be returned to Willowsway Stud immediately after insemination.
- Equitainers are subject to a £25 deposit, refundable upon return within 3 working days.
- Failure to return the equitainer within this timeframe will result in forfeiture of the deposit.

POSTAGE

- Willowsway Stud uses Royal Mail Special Delivery Service (guaranteed by 9:00am) unless alternative arrangements have been made by the mare owner (personal collection or private courier).
- Postage fees will be calculated based on the delivery address and advised at the time of booking.
- All semen shipments are sent via tracked/recorded delivery and are insured for consequential loss.
- The stud cannot be held responsible for delays or non-delivery by the postal or courier service.

VETERINARY DOCUMENTATION

- Mare owners must receive and retain the Semen Release Form from their veterinary surgeon.
- Veterinary surgeons must complete the Certificate of Insemination and Certificate of Pregnancy Diagnosis.

LIMITATIONS OF LIABILITY

- Willowsway Stud makes every effort to collect semen when requested; however, we cannot be held responsible for delay or non-availability of semen due to unforeseen circumstances.
- Every effort is made to ensure the mare receives the highest quality semen; however, no responsibility for damage to the condition of the semen or container can be accepted by the stud whilst in transit.

NO FOAL, FREE RETURN (NFFR)

- All stallions are offered on a No Foal, Free Return basis for the following year only.
- If a stallion is no longer available, the mare owner will have the opportunity to choose another available stallion.
- If the alternative stallion's stud fee is higher, the difference must be paid by the mare owner.
- No refunds will be given under any circumstances.

GENERAL CONDITIONS

- This agreement is for the above-named mare only and cannot be transferred to another mare.
- Willowsway Stud may consider exceptional circumstances at the discretion of the stud manager.
- This agreement is valid for the 2026 breeding season only.
